The Episcopal Diocese of Pennsylvania 2025 Elected Position Descriptions

The following list provides a brief summary of open positions in the Diocese and answers frequently asked questions.

Board of Trustees

The Diocese is incorporated as a non-profit corporation to carry out the business affairs of the Diocese. The Board of Trustees that has sole responsibility for administration of the business and financial affairs of the Diocese. The Board of Trustees consists of 13 members comprising the Bishop, 3 Clergy members elected at Convention on a staggered term basis, 6 Lay members elected at Convention on a staggered term basis, and 3 Lay members appointed by Bishop.

Church Foundation

The Church Foundation is a Pennsylvania nonprofit corporation managed by a Board of sixteen Directors. TCF serves as trustee, custodian and investment adviser for assets owned by churches, chapels, missions and institutions in the Diocese, and administers diocesan real estate matters as required. Members also serve on related subcommittees.

Residency Requirements: Clergy - Residency in Pennsylvania and canonically connected with the Diocese of Pennsylvania. **Lay -** Residency in Pennsylvania, a member of the Episcopal Church and affiliated with a Parish or Mission within the Diocese of Pennsylvania.

Helpful Skills/Experience: Knowledge of investments, trusts, finance, real estate, insurance, auditing, or other business-related expertise.

Commission on Wellness

The Commission on Wellness works on a variety of issues related to the health and wellness of Clergy and Lay employees of the diocese, including the topics of compensation, insurance, pension, and financial assistance.

Deputy to General Convention

Deputies to General Convention are elected to represent the Diocese at the 82nd General Convention of the Episcopal Church, July 2027 in Phoenix, Arizona.

Helpful Skills/Experience: Knowledge of the overall structure of the Episcopal Church. Familiarity with Church governance and parliamentary procedure.

Disciplinary Board

The Diocesan Disciplinary Board administers the process of dealing with complaints alleging clergy violation of the standards of clergy conduct as set forth in Title IV of the Canons of the Episcopal Church.

Helpful Skills/Experience: Attendance at meeting and training; willingness and ability to serve on a panel dealing with a complaint if chosen.

Nominating Committee

The Nominating Committee maintains and/or publicizes the descriptions and membership lists of all (non-paid) committee and commission positions in the diocese, works to recruit members for these positions, and presents a slate of candidates for election at diocesan convention.

Standing Committee

The Standing Committee is a body of advice and consent, working with the Diocesan Bishop, and is involved in making strategic decisions for both the Diocese and the Episcopal Church at large in raising up, calling and/or approving the call of candidates for ordination and the episcopate.
